ALL that certain tract or parcel of ground situate at 1918 10th Avenue, in the City of Altoona, County of Blair and Commonwealth of Pennsylvania, being bounded and described as follows:

BEGINNING at an iron pin set in the North right-of-way line of 10th Avenue, a twenty-eight(28) foot right- of-way at the Southeast corner of lands, now or formerly of Redevelopment Authority of Altoona, as recorded in Deed Book 1060, at page 591; thence, departing 10th Avenue and running along and with said Authority, North 23 degrees 55 minutes 38 seconds West, a distance of 105.47 feet to an iron pin set in the South side of a fourteen and a half (14.5) foot wide alley; thence departing said Authority and running along and with said alley, North 65 degrees 59 minutes 11 seconds East, a distance of 50.00 feet to an iron pin set at the Northwest corner of the lands, now or formerly, Redevelopment Authority of Altoona, as recorded in Deed Book 1054, Page 253; thence, departing said alley and running along and with the west line of said Authority, South 23 degrees 55 minutes 38 seconds East a distance of 105.48 feet to an iron pin set in the above-mentioned 10th Avenue right-of-way; thence departing said Authority and running along and with 10th Avenue, South 66 degrees 00 minutes 20 seconds West, a distance of 50.00 feet to the point of beginning. Containing 5274 square feet, more or less, as shown in more particular detail on a survey by Pellegrini Engineers, entitled, "Survey of Property for Catherine Yon", dated August 4, 1992, being attached to Blair County Deed Book Volume 1213 at Page 555 and incorporated by reference herein.

ALSO All that certain half lot or piece of ground lying and being situate in the City of Altoona, in the County of Blair and State of Pennsylvania, and being the western half of Lot No. 2, Block "C" and on the North side of 10. Avenue, between 19th and 20. Streets in said City of Altoona; containing in front or breadth of said 10th Avenue 25 feet and extending in length or depth the same width 120 feet more or less to an alley in the general plan of said Altoona City known as Londen's Hill, and being now known and designated as premises 1906 10th Avenue, Altoona PA.

FRONTING 50 feet on the North side of Tenth Avenue and extending back at the same width a distance of 106 feet to an alley and being the third lot West of 19th Street and known as Lot No. 3, Block "C" on Plan of that part of Altoona known as "Loudon's Hill." ALSO ALL that certain lot or parcel of land with the buildings and improvements thereon erected, situate, lying and being in the City of Altoona, County of Blair and State of Pennsylvania, and being bounded and described as follows: BEGINNING at a point on the northwestern side of Tenth Avenue, distant one hundred fifty (150) feet in a southwesterly direction from the point of intersection of the northwestern side of Tenth Avenue and the southwestern side of Nineteenth Street; thence in a northwestern direction a distance of one hundred twenty (120) feet to a point on a public alley; thence along and upon last mentioned line in a southwestern direction a distance of fifty (50) feet to a point; thence in a southeastern direction a distance of one hundred twenty (120) feet to a point on the northwestern side of Tenth Avenue; thence along and upon last mentioned line in a northeasterly direction a distance of fifty (50) feet to the point and place of beginning.
