ALL THAT CERTAIN lot or parcel of land, situate in the Borough of Tyrone, County of Blair and Commonwealth of Pennsylvania, bounded and described as follows:

BEGINNING at an iron pin on the Southeasterly line of Park Avenue at the Northwesterly corner of lands now or formerly of Daniel F. Meckes, South 54 degrees 36 minutes 00 seconds East, a distance of 59.87 feet to an iron pin on line of lands now or formerly of Conrail; thence, along same, South 32 degrees 36 minutes 11 seconds West, a distance of 110.13 feet (erroneously referred to as 110.00 feet in previous deed) to an iron pin on line of lands now or formerly of The Dominick Zang Estate; thence, along same, North 54 degrees 36 minutes 00 seconds West, a distance of 65.34 feet to a drill hole on the Southeasterly line of Park Avenue; thence, along the Southeasterly line of Park Avenue, North 35 degrees 27 minutes 00 seconds East, a distance of 110.00 feet to an iron pin, the point and place of BEGINNING.
